## **General product information**

The Relay Coupler Device type IMX12-CD01-2R-2U-0/L/\*\* is used for switching of intrinsically safe output signal on the field side by relay-contacts as well as for the safe galvanic separation between the intrinsically safe output circuits and the non-intrinsically safe input circuits.

In case of installation in zone 2, also non intrinsically safe signal circuits may be connected to the relay output signal circuits. The simultaneous connection of intrinsically safe and non intrinsically safe circuits is not allowed.

The permissible ambient temperature range is -25 °C up to +70 °C.
